

YU Journal of Medicine and Dentistry Article Instructions

The article should be between 7-10 pages in length (Including figures and references; 3000-5000 words)

Your article needs a descriptive title.(Not more than 14 words)

The purpose of the publication is for you to have the publication of your research, which can be listed on your resume.

If you do not have a topic, articles are available at PubMed (<https://pubmed.ncbi.nlm.nih.gov>)

You may also reach out to us for ideas.

Your article should include:

-Abstract (around 250 words) (No citations in the abstract)

-In the Abstract you will briefly describe the layout of your topic and how you develop the information in your different sections. Each sentence should introduce another step.

-Introduction (around 500 words)

-In the Introduction, you will give a more detailed description of the topic. Multiple sentences can describe each part of the topic.

-Body of the article should include appropriate subtitles (3-5 subtitles in total).

- In the Body of your article you will go through different areas relating to your topic.

These should build on each other. If you are using a topic from an article you found on PubMed, **DO NOT** just use that article as your only source of information. Search up other articles on PubMed about the topic. There may not be an article on the exact same topic, however, you may look up things mentioned in your first article and discuss them further in your sections. Perhaps look in the citations of the first article and discuss it in greater detail than that article had.

This is how you make the article yours!

-**FIGURES** - In your article you are highly encouraged to include 3-5 of any combination of the following: Pictures, Diagrams, Tables, Charts, etc... Please note that you cannot copy any of those from the articles you read. You may recreate those figures using websites below:

A great website to use to make new figures that you want or recreate figures from articles that you saw is Biorender. Here is the link: [BioRender](#)

-Conclusion

- In the Conclusion of your article, you will give a summary of the sections of your article. This will be relatively similar to your abstract. However, you will also add your thoughts about what could be done to better understand the topic. You may also include latest development in the field.

-References

-You should include **at least** 10 references and they should be PubMed-level publications. No blog or newspaper or so... It sounds like a lot, however, once you start looking up certain terms, you will find articles all about them, which you cite.

*Your article should also include numbers that correspond to reference numbers, end notes, NOT footnotes. We recommend that you use Microsoft Word, which has an endnote function. Google Docs does not have an option for Endnotes. If you write it in Google Docs, it will require you to manually add each reference by using the superscript function. Then, if you add or take away another reference in between references, you will need to change many numbers.

Please note: We are not looking for you to compile information online on a known topic. There must be a novel element to your article, you have to ask a question and answer it. (Through online research or clinical or lab research)

You do not need to write your article in a particular font or size, we will be changing everything into the journal's unique font and layout.

Submitting your article:

You must submit the article by the deadline, you will submit your article on google docs, sharing it with your editor, who will reach out to you with their email. We highly recommend that you share the document even before the deadline so that your editor can already start helping you earlier.

The deadline to submit your complete article is **December 1st, 2022.**

By this date, you MUST have a complete article to share with your editor, who will then get back to you with edits. They will provide you with edits to make within the week and you must resubmit your completed article by **December 15th, 2022.** This will include adding or removing information based on the editor's notes and approving grammar corrections that they make for you.

These deadlines are so that the faculty advisor, Professor Maitra, will have time to review the articles before printing during winter break.
